To Acquire Additional Property

**NOTE:** This form is used by a buyer's agent when negotiating the purchase of one property and concurrently acquiring the right to buy another property if the owner decides to sell it, to prepare the grant of the right of first refusal as an addendum to a purchase agreement.

- 3.3 Any sale on different terms reinstates the Buyer's right of first refusal.

4. If Seller has not closed a sale of the property within six (6) \_\_\_\_\_ months after Buyer's receipt of Seller's notice, Buyer's right of first refusal is reinstated.
