

48-HOUR NOTICE OF INTENT TO ENTER DWELLING

Pre-Termination Inspection

NOTE: This form is used by a property manager or landlord when responding to a tenant's request for a joint pre-termination inspection of the premises, to notify the tenant of the hour and date the inspection will take place for which they may be present, or obtain the tenant's waiver of their right to 48-hour advance notice before the inspection is to take place.

 - 2.1 The inspection may not be scheduled earlier than two weeks before your tenancy expires or terminates.
 - 2.2 The date and time scheduled for the inspection is the result of Landlord's attempt to set a mutually acceptable date and time so you can be present.

NOTICE TO TENANT:

3. Landlord or their agent will enter the above premises at or about the normal business hour of _____, on _____, 20_____, to conduct an inspection of the premises and provide you with a written itemized statement of deficiencies specifying repairs and cleaning necessary to be remedied or eliminated by you to avoid a deduction of their costs from your security deposit.

5. **Waiver:** Valid only if signed by both Tenant and Landlord or their agent.

- 5.1 This waiver pertains to the requirement in Civil Code §1950.5(f)(1) calling for at least 48 hours prior written notice of the date and time for the joint pre-termination inspection requested by Tenant.
- 5.2 Tenant and Landlord hereby waive and agree to forego the 48-hour notice of intent to enter the dwelling, and agree to hold the inspection on the date scheduled below.
